Participation regulation

- The condition of participation is the submission of the registration form and the effect of payment of ordered space and furniture within deadline or on the location in cash.
- In case the registered exhibitor is not present on the opening day for any reason, the granted exhibition space can be cancelled and filled with other applicants. No refund is available.
- A filled in and signed registration form is qualified as a standard contract.
- To drill, nail or cut the exhibition installation is prohibited. The damage caused is to be compensated on the location by the exhibitor.
- Any damage caused to the organiser, or to any other exhibitor during the assembly, exposition and disassembly intervals is bound to be compensated by the originator either via insurance or by cash on the location.
- In case the objects exhibited do not suit the topic of the trade fair, the granted exhibition stand may be withdrawn.
- As offset of any service unpaid until the closure of the fair, the organiser has a right of lien for all the exhibitors goods brought to the fairgrounds without regard of the ownership of any asset, equipment or exhibit.
- Allocation will be by the order of registration. The assignment of areas is in the jurisdiction of the organiser.
- By building a custom installation, the exhibitor takes notice of the obligation to build an aesthetic border between the onwned and the neighbouring stalls by means of unique or stock installation with the minimum height of 2,5 m.
- Custom installations will have to comply with aesthetic and static requirements.
- The time of fare closure should be strictly adhered to. The exhibitor is not allowed to remove the exhibits from the exhibition stand until the exhibition is over.
- The keys to the vehicles on display are to be kept at the information counter every night.
- Keeping the fire regulations of the trade fair is obligatory.
- Insurance payment is obligatory.

Additional Information

Outdoor space order implies solid covered surface to build installations, tents and park trailers.

Fascia banner or indication of the name of the company is obligatory.

Security: The organiser provides security service from closing time to opening time on each fairday only. During the whole time of assembly and disassembly as well as the working hours of the fair the exhibitor is responsible for the assets, equipment and vehicles brought to the fairgrounds.
